The Original Sovereign Tribal Federation (OSTF), Hereby certify that the bearer of this Certificate, (herein the Protected Woman/Man/Child), is the Living Flesh and Blood Woman/Man/Child and he/she as the bearer of this instrument is afforded the protection of the terms of the OSTF Discretionary Trust (herein the Trust) as recognized and Apostilled by the Crown in the Right of THE COMMONWEALTH OF AUSTRALIA on the 6<sup>th</sup> Day of May 2019 [*Crown ID No: HFAF-JN-1722*]

This Certificate of Protection is registered within the OSTF data base and the Holders' identification details are also held for future reference and legal reasons.

Anyone wanting to engage the Protected Woman/Man/Child, without the written consent of the Original Sovereign Tribal Federation (OSTF) Trust will incur the following currency charges:

1. Initial cost is of the equivalent value of 20 (twenty) ounces of pure gold and for every 5 minutes and part thereof is 5 (five) ounces of gold.
2. Those charges are applicable to Any and all Federal, State or Territorial Governments and any and all of their Agents and heirs, successors, assign, executors or administrators in both their personal and commercial personas.

And further,

3. The Protected Woman/Man/Child is afforded the protection of the Terms of the Trust notwithstanding the fact the Protected Woman/Man/Child might be recognised as being an Australian or any other "Citizen" and the Protected Woman/Man/Child is to be treated by Any and all Federal, State or Territorial Governments and any and all of their Agents and heirs, successors, assign, executors or administrators as though the Protected Woman/Man/Child were in fact a Tribal person.



4. The Protected Woman/Man/Child is free from the implications and or requirements, instructions, orders, actions or other advices of any and all Federal, State or Territorial Orders, Mandates, Requirements or other purported reasons to be tested, treated and or vaccinated for the Covid-19 virus – regardless of strain, type and or other Covid variant.
5. The Protected Woman/Man/Child is free to travel across the joint and several Tribal Estates on this continent in accord with the OSTF Treaty. The Protected Woman/Mans' right to travel across the Tribal Estates is not limited by any requirement, Order, Mandate or other purported or actual reason of Any and all Federal, State or Territorial Governments and any and all of their Agents and heirs, successors, assign, executors or administrators.
6. You, by reading and or being presented with this document are considered to have been served and agreed to its' contents and you have now entered into a legal contract with the Original Sovereign Tribal Federation (OSTF) in respect of this Certificate and the Protected Woman/Man/Child and failure to adhere to the rights extended to the herein will incur the charges identified in clause 1, above.
7. The Original Tribes and Sovereigns of Terra Australis, here-by Declare that we have exercised and are exercising our right to self determination *[as recognized by, among other instruments, United Nations Resolution 2625 (XXV)]* and our inherent and indisputable Sovereignty over our joint and several Tribal Estates, and having united with the Original Tribes and Sovereigns of Terra Australis as a People to create the Original Sovereign Tribal Federation (the OSTF) so as to unify the Original Tribal Peoples under the authority and blessing of the Creator commensurate with our Law, as recognized by the Crown in the Right of the COMMONWEALTH OF AUSTRALIA on the 6<sup>th</sup> Day of May 2019 and by its' High Court by way of Judgment in Love V The Crown on 10<sup>th</sup> February 2020.
